HOW TO ENTER

Entrants must upload their photo and also fill out all required fields on the entry form to participate in the challenge. After submitting the photo and the required information on the entry form, the Entrant will receive one (1) entry into the drawing. You may enter only once.

Photos that have been digitally altered beyond standard optimization (removal of dust, cropping, reasonable adjustments to exposure, color and contrast, etc.) will be disqualified.

The basement must be the property of Entrant or an immediate relative of Entrant; the basement photograph, in its entirety, must be a single work of original material taken by the Challenge Entrant.
